Tissue is the Issue

Tissue is Sexy?!

While attending the International Symposium of Pediatric Neuro-Oncology we heard many researchers talk about the need for tissue to study, including Dr. Stefan Pfister of Heidelberg University Hospital. He said, **"tissue is not sexy but it is the most fundamental thing philanthropy can fund.** Only through tissue can we understand the heterogeneity of tumors and start constructive research projects. Furthermore, it is impossible to get government funding for tissue donation and insurance won't cover it." But, as you know, Swifty does!!

Tissue is not sexy because the cure will be found in a clinical trial, the final step in the research process. Understandably, most funders want to fund the final step. But tissue is required in all the steps leading up to the trial. **No tissue, no trial.** Just as no one sees the foundation of your house, we all know without that foundation, there wouldn't be a home for your family to gather in.

Swifty is helping build the foundation for the clinical trials that will lead to the cure and perhaps **redefining what sexy is.** Michael, who chose to donate his tissue is pictured here in one of his favorite hats. He knew a little something about redefining sexy.

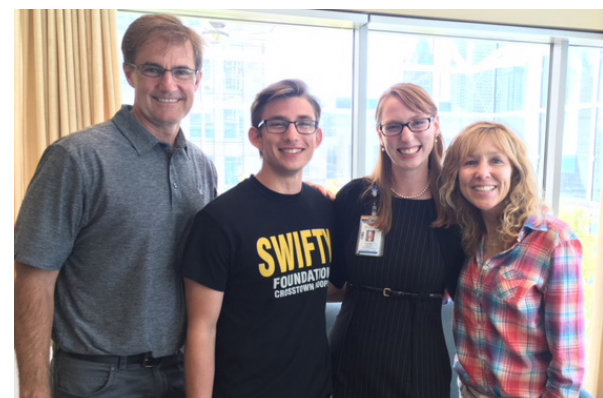


A Tissue Navigator

Our 2017 Annual Appeal focused on raising money to fund a Tissue Navigator at Lurie Children's Hospital in Chicago. **You responded so generously...** thank you! We presented Lurie a check for the first installment of the \$300,000 grant at the end of 2017.

In May of 2018, **Kayleigh Eisenstein became the first pediatric Tissue Navigator in the country** and she has hit the ground running! She has formalized an autopsy donation protocol at Lurie modeled after the program Swifty started at the Children's Hospital of Philadelphia. Her primary role is to provide services to children and families that will increase the number of tissue donations at the time of diagnosis, recurrence and autopsy. Not only will she be working with the patients at Lurie, but she will also be coordinating tissue donations from smaller regional hospitals.

Our first impression of Kayleigh is she has the **right combination of compassion and enthusiasm** that makes her perfect for this important work.

California Here We Come!

We began in Philadelphia, moved to Chicago, and now in order to create a coast to coast network of the best children's research institutions focused on increasing post mortem donations, we are looking to California, specifically to the lab of Dr. Michelle Monje at Stanford. We have been in conversation with Dr. Monje and hope to finalize plans for a Tissue Navigator at Stanford when we visit her lab in August. Stay Tuned!

When a life ends far too soon and science receives the precious gift of a child's tissue, we must guarantee the way the tissue is collected and processed ensures all possible opportunities for future research.

Our Big Hairy Audacious Goal

Swifty's ultimate vision is to develop 5 Integrated Regional Centers of Excellence for tissue collection and processing across the country. These regional centers must be able to process whole brain and spine donations. The donation protocol will be standardized among the five centers. In addition to tissue, other bio-specimen and clinical data from the patient and parents will also be collected.

Then all the data that the gift generates will be collected and shared throughout the research community in order to assure the child's gift makes the greatest impact possible.

SWIFTY SPOTLIGHT: **Junior Board Member, Kira Couch**

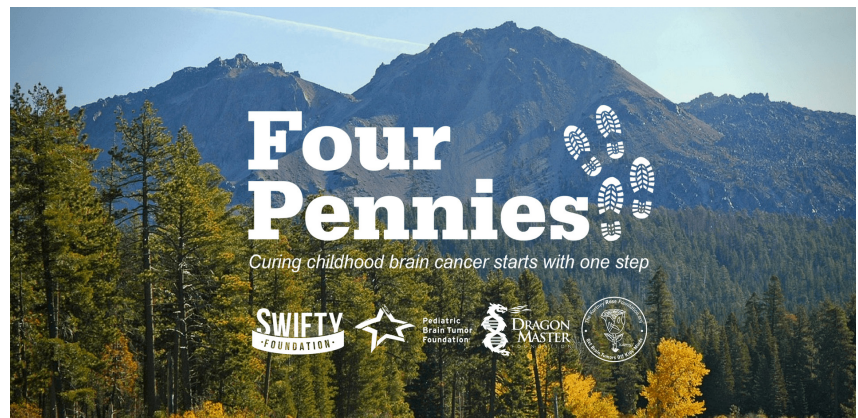

Four Pennies

When Eric Montgomery told us he was going to take four months of his gap year before he starts medical school to hike 2659 miles on the Pacific Crest Trail and raise \$5200 for Swifty, we were inspired. His herculean effort inspired us to make his hike bigger than Swifty! We recruited three other pediatric foundations and branded the hike Four Pennies ... to remind donors that the National Cancer Institute spends only 4 pennies of every federal dollar available for research on **children’s** cancer research.

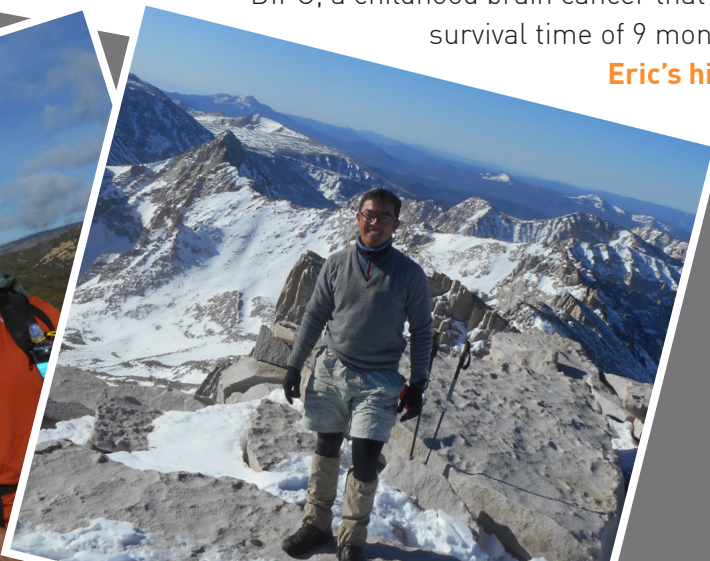


Working together, our four foundations aimed to raise four pennies for each of the 4.6 million steps

Eric would take on his hike. Every dollar raised supports a collaborative research project targeting DIPG, a childhood brain cancer that is always fatal and has a median survival time of 9 months. At the time of this writing,

Eric’s hike has raised more than \$125,000!

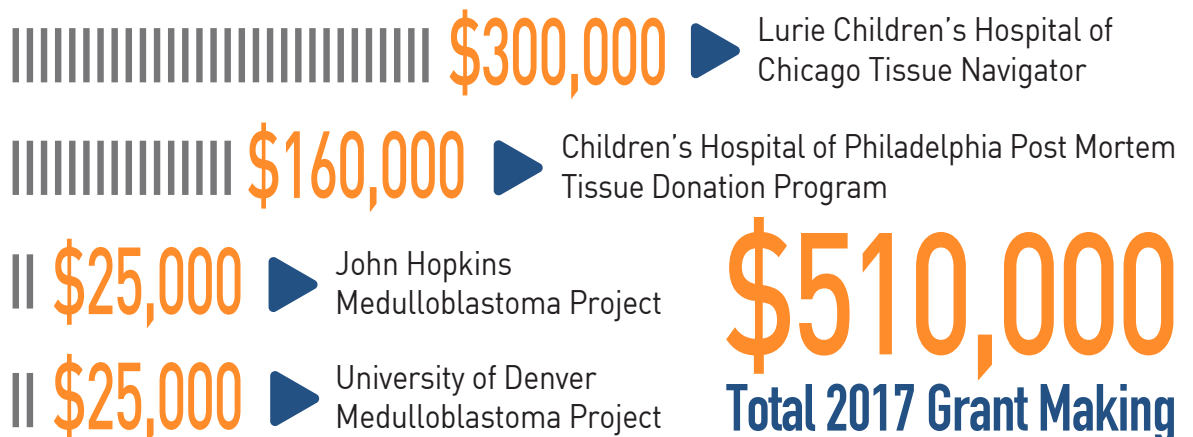
